Cleveland Haunt Club Halfway to Halloween Flea Market participants are welcome to sell and/or promote new/crafted/created/and/or gently used merchandise/items/services/or activities that in some way relates to Halloween, Horror Genre and or Haunting.

Space rental fees are \$80.00 (\$70.00 for Paid members)

Each vendor space is 10ft x 10ft. **All items must remain inside your 10x10 space. NO**

**EXCEPTIONS!** If you need additional space you will need to purchase another booth. Since we are indoors you will not have access to the sides or back area of your booth from outside.

1- 8ft table and 2 chairs will be supplied for each 10x10 space. Additional Tables are available for \$2.50. Additional chairs are available for \$.50 cents each. You are welcomed to bring your own tables.

We will try our best to accommodate any special request by any vendor in the order the requests are received.

Vendors will receive a confirmation of their accepted registration when received by event chairperson. The Cleveland Haunt Club reserves the right to reject any contract submitted by a vendor.

The sale of firearms, ammunition, pornographic material alcoholic beverages and food and/or beverages is strictly prohibited.

No vendor will be permitted to conduct a raffle or games of chance. Any vendor not adhering to these strict restrictions may be removed by the Cleveland Haunt Club.

No responsibility will be assumed by the Cleveland Haunt Club, Medina County Agricultural Society, and Medina County Commissioners for any theft or damage to objects displayed or for damage by reason of injury to property or persons.

Vendors will be responsible for any damages or fees/costs resulting from negligence of himself/herself, his/her family, his/her employees or his/her agents.

Vendors agree to indemnify and hold harmless the Cleveland Haunt Club, Medina County Agricultural Society, and Medina County Commissioners from any and all claims for damage or injury to personal property or persons occurring during the Cleveland Haunt Club Flea Market.

Another booth will be next to you and behind you.

**Due to fire code restrictions nothing can be located outside of your booth in front.**

SET UP:

May 23th at 7:00 a.m. (NOT BEFORE)

Vendors will be permitted to set up Saturday, Set up must be completed by 9:45am CLEAN UP Break down begins at 4:00 pm unless a vendor sells out earlier. Each vendor is expected to clean up their space at the end of the day and remove all refuse, boxes, papers, and unsold merchandise. The spaces rented by the Vendor must be left as clean as at the beginning of the set up.
